- **The guarantee element of Pension Credit**
- **Child Tax Credit and your annual gross income is no more than £16,190 and you don't also receive Working Tax Credit**
- **Working Tax Credit run-on (paid for 4 weeks after you stop qualifying for Working Tax Credit)**

If you received Free Meals at school, you will need to reapply online as this data does not transfer over.
